justice. Since the 1960's, he has called attention to parallels between the environmental, civil rights, labor, and peace movements, and connected environmental decline with poverty, injustice, exploitation, and war, arguing that the root cause of environmental problems was the American economic system and its manifestations. He was instrumental in pointing out that there was a direct association between socioeconomic standing and exposure to environmental pollutants and that economics, not social responsibility, was guiding technological decision making. Egan argues that careful study of Commoner's career could help reinvigorate the contemporary environmental movement at a point when the environmental stakes have never been so high."--
