Sommario/riassunto	Les transformations organisationnelles qui accompagnent l'évolution du capitalisme depuis 30 ans donnent une place centrale à la communication. Celle-ci est généralement appréhendée dans une optique descriptive d'étude des organisations, ou comme dispositif au service de la performance. Il existe cependant une tradition de recherche qui l'aborde dans une perspective critique. C'est à cette orientation que cet ouvrage est consacré : Qu'est-ce qu'une recherche critique en communication des organisations ? Quelles catégories de la critique (aliénation, exploitation, domination...) sont convoquées ? Quels sont les fondements théoriques et épistémologiques d'une telle démarche ? Quelles sont les méthodes utilisées ? Sur quels objets portent les travaux ? Et quels en sont les enjeux ? Sur ces thèmes, cet ouvrage a le mérite de réunir pour la première fois, et de faire dialoguer entre eux, plus de trente chercheurs de pays et de disciplines différentes principalement en sciences de l'information et de la communication, sciences de gestion et sociologie. Les orientations de

la critique y sont variées : de la critique épistémologique à la critique socio-politique, de la critique d'une organisation particulière à celle du capitalisme, de la nuance prudente à la radicalité « ouvrante »... Son ambition est d'être une référence ou un repère, d'encourager le débat sur une démarche plus que jamais nécessaire. Il intéressera un large public : chercheurs, enseignants et étudiants en particulier en gestion, SIC ou sociologie des organisations ; acteurs impliqués dans le fonctionnement des organisations (syndicalistes, DRH, communicants...).

Sommario/riassunto

This book, in its second edition, introduces readers to the economics of immigration, which is a booming field within economics. The main themes and objectives of the book are for readers to understand the decision to migrate, the impacts of immigration on markets and government budgets and the consequences of immigration policies in a global context. Our goal is for readers to be able to make informed economic arguments about key issues related to immigration around the world. This book applies economic tools to the topic of immigration to answer questions like whether immigration raises or lowers the standard of living of people in a country. The book examines many other consequences of immigration as well, such as the effect on tax revenues and government expenditures, the effect on how and what firms decide to produce and the effect on income inequality, to name just a few. It also examines questions like what determines whether people choose to move and where they decide to go. It even examines how immigration affects the ethnic diversity of restaurants and financial markets. Readers will learn how to apply economic tools to the topic of immigration. Immigration is frequently in the news as more people move around the world to work, to study and to join family members. The economics of immigration has important policy implications. Immigration policy is controversial in many countries.

This book explains why this is so and equips the reader to understand and contribute to policy debates on this important topic.
