procédure parlementaire du vote du budget annuel et du contrôle de l'exécution des exercices passés, développement du principe de la spécialité budgétaire, régularisation du mouvement général des fonds en relation avec la Banque de France et l'utilisation de bons du Trésor, réglementation de la comptabilité publique... Seule survivance archaïque : le recours à l'emprunt en perpétuel, ce qui posa le problème de la diversification du taux des emprunts, de la conversion des rentes et de l'amortissement de la dette. Le budget annuel, de 900 millions en 1816, s'éleva à près d'un milliard et demi en 1848, la politique des grands travaux, en particulier la construction des chemins de fer, ayant creusé un déficit croissant à partir de 1840, ce qui compromit la solidité du régime.
