Sommario/riassunto	Foundations of Jurisprudence: An Introduction to Imm Sh Legal Theory is a critical edition of the Arabic text with a parallel English translation of Mabdi al-wul il ilm al-ul by al-Allmah al-ill,

introduced, edited and translated by Sayyid Amjad H. Shah Naqavi. Al-Allmah al-ill participated in the leading debates of his day and applied his vast erudition in philosophy, logic, and theology to the paramount subject of jurisprudence. This text presents an exemplar of the rich revival of Sh scholarship in the thirteenth and fourteenth centuries of the Common Era. Concise, yet comprehensive, this work sets the standard for the subsequent development and discussion of Imm Sh legal theory, such that its influence can be traced through to modern times. This dual-text edition is indispensable for students and scholars of Immi Sh jurisprudence.
