Sommario/riassunto	Bien éclairée par les cartulaires ecclésiastiques à partir des années 1070-1080, la société du Bordelais offre une organisation des pouvoirs particulière. Cette étude montre que la figure ducale, habituellement minorée par l'historiographie, peut être réévaluée. À la tête d'un domaine dont l'emprise territoriale est reconstituée, dominant un tissu

seigneurial marqué par des seigneuries locales et des seigneuries châtelaines ne lui portant pas ombrage, le duc d'Aquitaine reste dans cette partie de la Gascogne, en dépit de ses absences, une figure majeure. La paysannerie libre y est importante. Le mariage d'Aliénor d'Aquitaine et d'Henri II Plantagenêt change la donne (1152). Dans les décennies qui suivent, le roi d'Angleterre et son fils, Richard Cœur de Lion, engagés dans de fréquents conflits, imposent un renforcement de leur autorité par l'introduction de nouvelles coutumes féodales, le relèvement de la fiscalité et par le biais de la paix du roi. Les liens sont renforcés avec l'aristocratie, nettement militarisée, ainsi qu'avec les communautés, requises au service militaire ou associées à la perception des revenus publics. Les années 1180 marquent l'acmé de ce premier temps du roi-duc.

Sommario/riassunto

"This edited collection focuses on Aboriginal and Mori travel in colonial contexts. Authors in this collection examine the ways that Indigenous people moved and their motivations for doing so. Chapters consider the cultural aspects of travel for Indigenous communities on both sides of the Tasman. Contributors examine Indigenous purposes for mobility, including for community and individual economic wellbeing, to meet other Indigenous or non-Indigenous peoples and experience different cultures, and to gather knowledge or experience, or to escape from colonial intrusion.

'This volume is the first to take up three challenges in histories of Indigenous mobilities. First, it analyses both mobility and emplacement. Challenging stereotypes of Indigenous people as either fixed or mobile, chapters deconstruct issues with ramifications for contemporary politics and analyses of Indigenous society and of rural and national histories. As such, it is a welcome intervention in a wide range of urgent issues. Second, by examining Indigenous peoples in both Australia and New Zealand, this volume is an innovative step in removing the artificial divisions that have arisen from "national" histories. Third, the collection connects the experiences of colonised Indigenous peoples with those of their colonisers, shifting the long-held stereotypes of Indigenous powerlessness. Chapters then convincingly demonstrate the agency of colonised peoples in shaping the actions and the mobility itself of the colonisers.

While the volume overall is aimed at opening up new research questions, and so invites later and even more innovative work, this volume will stand as an important guide to the directions such future work might take.'

Sommario/riassunto	This work presents a comparative analysis of different types of logic cuts obtained using the dual surrogate properties of multidimensional knapsack problems. Constraint pairing and an initial integer solution are used to combine the dual surrogate constraint with the objective function and generate new constraints. These constraints are used to obtain different type of logic cuts and these cuts are included in the model before solving the problem to optimality with branch and bound. Computational tests were performed in the set of small problems and the first subset of big instances in the OR-library. It can be seen that the presence of logic cuts in the model improved the branch and bound performance lowering the number of nodes in the search tree.
