Sommario/riassunto	This book studies the early development of Skanda-Krttikeya's Hindu cult from its earliest textual and material sources to the end of the Gupta Empire in the north of India. The text argues that Skanda's early 'popular' cult is found in Graha and Mt traditions oriented towards appeasing potentially dangerous spirits. Once propitiated, however, Skanda and his Grahās/ Mts could become fierce protectors of their followers. During the Kua and Gupta empires, this tradition gains

the attention of rulers, who transform the deity's protective cult into one focused on the ruler's military prowess and right to rule. Once detached from his former popular traditions the deity's cult begins to falter in the north as it becomes increasingly focused on elite agendas.

Sommario/riassunto

This study compared the Applied Behavior Analysis benefit provided by TRICARE as an early intervention for autism spectrum disorder with similar benefits in Medicaid and commercial health insurance plans. The study focused on comparing a proposed TRICARE reimbursement rate decrease from \$125 per hour to \$68 per hour for such services performed by a Board Certified Behavior Analyst to reimbursement rates in other plans.
