Written by authors with a sound academic background and professional involvement in policy relevant research, this volume focuses on priorities in implementation of the Global Compact in the Global South. It is addressed to a broad readership interested or involved in international migration governance, development studies, and regional studies, from a research as well as a policy perspective.
