Sommario/riassunto

Coverage includes detailed analyses of Hungarian minority parties in Romania, Albanian minority parties in Macedonia, Serb minority parties in Croatia, Bosniak minority parties in Serbia, and various minority parties in Montenegro, as well as the Movement for Rights and Freedoms, a largely Turkish party, in Bulgaria.
