#### Sommario/riassunto

This two-volume book collects the lectures given during the three months cycle of lectures held in Northern Italy between May and July of 2001 to commemorate Professor Bernard Dwork (1923 - 1998). It presents a wide-ranging overview of some of the most active areas of contemporary research in arithmetic algebraic geometry, with special emphasis on the geometric applications of the  $p$ -adic analytic techniques originating in Dwork's work, their connection to various recent cohomology theories and to modular forms. The two volumes contain both important new research and illuminating survey articles

Sommario/riassunto	Fondateur de l'anatomie comparée et figure centrale de la biologie du XIXe siècle, Georges Cuvier a réuni avec l'aide de son élève et collègue Achille -Valenciennes tout ce que l'on savait sur les -poissons dans leur imposante Histoire naturelle des poissons publiée en 22 -volumes de 1828 à 1849. -Malgré les années, ce travail demeure un jalon dans l'histoire des sciences et continue à être mobilisé par l'ichtyologie systématique et la biologie comparée en général. A founder of comparative anatomy and a giant of nineteenth-century biology, Georges Cuvier, and his student and colleague Achille Valenciennes, brought together all that was known about fishes in their massive 22-volume *Histoire naturelle des poissons* published from 1828 to 1849. Despite the passage of time, this work represents a landmark in the history of science, indispensable to systematic ichthyology and to comparative biology in general. As an introduction to this monumental work, the first volume traces the development of the study of fishes as then understood—from the earliest beginnings to the first third of the nineteenth-century—and summarizes the criteria for classification that their own work would follow. This critically important essay—one of the first attempts at a comprehensive history...
