Sommario/riassunto	This study breaks new ground in describing how various linguistic and pragmatic mechanisms affect both the form of the narrative clause and the arrangement of the grammatical elements. The various possible forms that a narrative clause can take are classified in terms of their 'topic-comment' and 'focus-presupposition', and it is argued that the way in which these are articulated dictates the word order in the clause. The outcome of the study demonstrates that the traditional binary

distinction between foreground and background, based purely on verb forms, is inadequate. A new model is offered

Sommario/riassunto	América Latina está pasando desde hace varios años por una crisis política, económica y social cuya seriedad es cada vez más palpable. El primer ensayo de este trabajo evalúa el nuevo Tratado de Montevideo (1980) y su relevancia para el desarrollo económico y social de la región en el decenio de los ochenta; el segundo analiza las perspectivas socioeconómicas de la subregión centroamericana en los años venideros y las posibilidades futuras de integración en esta área latinoamericana tan convulsa.
