By establishing a new capital for the Roman Empire, Constantine and his formidable mother, Helena, initiated its Christian transformation. Over time this transformation

empowered imperial women, transformed the cult of the Virgin Mary, fueled contests between church and state, and provoked an arresting synthesis of imperial and Christian art.
