Das geschieht aber nicht nur aus theologiegeschichtlichem Interesse, sondern auch im Blick darauf, welche Impulse diese Entwürfe der heutigen Diskussion geben können. Wenn sie auch ihrer Zeit verhaftet sind, so behandeln sie doch Grundfragen, die sich stellen, wenn man Religion und Religionen zum Thema der Theologie macht.
