Sommario/riassunto	L'Europe est-elle un espace de représentation et d'action politique incontournable ? En prenant pour objet la Confédération paysanne et ses représentants nationaux, cet ouvrage analyse la manière dont un syndicat se saisit (ou non) de l'Europe pour en contester la politique. Grâce à une enquête qui mêle archives, entretiens approfondis, observations sur le terrain et traitement d'un questionnaire, l'auteure invite à une plongée dans le travail de production et de représentation des positionnements syndicaux face à un défi majeur : la politique agricole commune (PAC). En questionnant les conditions sociales du passage à l'Europe, l'étude déploie aussi une sociologie de l'européanisation et bat en brèche la fausse évidence d'une scène

ouverte à la défense de tous les intérêts et s'imposant comme nouvelle opportunité politique. L'Europe n'est toutefois pas sans effet sur l'organisation syndicale : les débats internes sur la PAC révèlent les tensions relatives aux modalités d'action ainsi qu'un processus de spécialisation du travail militant.

Sommario/riassunto	"The book examines whether the jurisdiction of coastal States under international law can be extended to include powers of intervention towards vessels posing a significant risk to their coastal and marine environment, but which have not yet been involved in any incident or

accident. The book sets out how it is that coastal State jurisdiction can indeed be seen as including powers of intervention towards High Risk Vessels before an incident or accident happens, on the basis of the precautionary principle. The precautionary principle requires taking action when a risk of damage to the environment is suspected, but cannot be confirmed scientifically. The book thus considers the potential opportunities for the coastal state under international law to regulate international shipping where they consider vessels to be an unacceptable risk to the environment, in order to prevent or minimise the risk of occurrence of the accident or incident leading to damage. The book acknowledges that this puts into question some very old and established principles of the law of the sea, most importantly the principle of freedom of navigation. But Benedicte Sage-Fuller contends that this change would itself be a consequence of the evolution, since the end of WWII, of on the one hand international law of the sea itself, and of international environmental law on the other hand. During the writing process the author consulted maritime government departments and maritime safety agencies so as well as considering issues of jurisdiction the book also addresses the practical considerations inherent in protecting coasts from environmental harm"

Sommario/riassunto	This book provides an in-depth account of a qualitative study on the familial arrangements and domestic settings shaping interracial gay partnerships in the South African context, and it offers both empirical and theoretical insights on the topic. While heterosexual intimate relationships, particularly mixed-race couples, have attracted societal and scholarly attention in South Africa due to the country's past history of racial segregation, it is, however, striking how little emphasis is

placed on understanding same-sex unions in a transforming South Africa. This book is timely and important because it explores the vignettes, complexities and dynamics of interracial gay intimate relationships, an area that hardly gets the scholarly attention it deserves. The book addresses the intersectionality, and the question of how sexuality, gender, racial identity and personal resources influence the relationship as well as the way resilience strategies are drawn upon to sustain the partnership.
