Sommario/riassunto	This book contributes to discussion on the ageing society by addressing the new psycho-social structures of the ageing society, the problematics around family bonds and ties, and the structures of care and protection. Besides that the book sheds light on the new roles of grandparents and new grandparents, and the empowerment and resilience initiatives, thereby providing a broad discussion of what the ageing society implies in psychosocial terms.
