Sommario/riassunto

In Nazi eyes, the Soviet Union was the "wild east," a savage region ripe for exploitation, its subhuman inhabitants destined for extermination or helotry. An especially brutal dimension of the German army's eastern war was its anti-partisan campaign. This conflict brought death and destruction to thousands of Soviet civilians, and has been held as a prime example of ordinary German soldiers participating in the Nazi regime's annihilation policies. Ben Shepherd enters the heated debate over the wartime behavior of the Wehrmacht in a detailed study of the motivation and conduct of its anti-partisan campaign in the Soviet Union. He investigates how anti-partisan warfare was conducted, not by the generals, but by the far more numerous, average Germans serving as officers in the field. What shaped their behavior was more complex than Nazi ideology alone. The influence of German society, as well as of party and army, together with officers' grueling yet diverse experience of their environment and enemy, made them perceive the anti-partisan war in varied ways. Reactions ranged from extreme brutality to relative restraint; some sought less to terrorize the native population than to try to win it over. The emerging picture does not dilute the suffering the Wehrmacht's eastern war inflicted. It shows, however, that properly judging ordinary Germans' role in that war is more complicated than is indicated by either wholesale condemnation or wholesale exoneration. This valuable study offers a nuanced discussion of the diversity of behaviors within the German army, as well as providing a compelling exploration of the war and counterinsurgency operations on the eastern front.

Sommario/riassunto	<p>Parmi les questions auxquelles l'histoire de la Révolution française n'a pas donné de réponses définitives, la définition « du » politique demeure toujours irrésolue. Cette indécision est d'autant plus grande que l'historiographie actuelle ne s'intéresse plus seulement aux « grands » hommes mais qu'elle prend en compte les multiples interventions dans le « domaine politique ». Entrent en ligne de compte toutes les actions symboliques et culturelles qui donnent du sens à la période. Au premier plan des interrogations se trouvent alors les représentations que les hommes et les femmes de la fin du xviiie et du début du xixe siècles ont mobilisées pour peser sur le destin collectif. L'objet du livre est l'étude de la confrontation de ces représentations mentales, linguistiques, iconographiques et rituelles et du pouvoir, exercé, contesté, imaginé pour bâtir « le » politique. L'ouvrage rassemble les communications présentées lors d'un colloque international tenu à Paris en juin 2004, réunissant des spécialistes</p>

français, américains et allemands. Tout l'éventail des médias, des pratiques et des espaces de « la politique symbolique » a été parcouru par les auteurs : de la peinture aux symboles abstraits et aux arts graphiques, des discours et des pamphlets politiques aux chansons révolutionnaires, du théâtre et des fêtes aux banquets et aux cérémonies funéraires. Entre 1789-1830 la lutte est permanente autour de telles représentations. Les acteurs politiques rivalisent entre eux pour accaparer le pouvoir d'interprétation officiel et imposer leur propre vision de « l'unique » représentation de la société. Or aucune interprétation officielle ne survit pendant longtemps. Le présent volume participe au débat sur le caractère intrinsèque de la société contemporaine, condamnée à gérer la tension inévitable entre sa volonté d'unité et les conflits qui la menacent. Comme pour d'autres domaines, la Révolution française est bien ce « laboratoire » contenant en germe les éléments...
