In Freedom to Serve, Jon E. Taylor gives an account of the presidential order as an event which forever changed the U.S. armed forces, and set a political precedent for the burgeoning civil rights movement

Lastly, it contains a selection of numerical

applications, including recent research results on nonlinear function approximation by exponential sums. The code of most of the presented algorithms is available in the authors' public domain software packages. Students and researchers alike benefit from this unified presentation of Fourier theory and corresponding algorithms.
