Sommario/riassunto	Integrals and sums are not generally considered for evaluation using complex integration. This book proposes techniques that mainly use complex integration and are quite different from those in the existing texts. Such techniques, ostensibly taught in Complex Analysis courses to undergraduate students who have had two semesters of calculus, are usually limited to a very small set of problems. Few practitioners consider complex integration as a tool for computing difficult integrals. While there are a number of books on the market that provide tutorials on this subject, the existing texts in this field focus on real methods. Accordingly, this book offers an eye-opening experience for computation enthusiasts used to relying on clever substitutions and transformations to evaluate integrals and sums. The book is the result of nine years of providing solutions to difficult calculus problems on forums such as Math Stack Exchange or the author's website, residuethorem.com . It serves to detail to the enthusiastic mathematics undergraduate, or the physics or engineering graduate student, the art and science of evaluating difficult integrals, sums, and products.

Sommario/riassunto	Lucian (ca. 120-190 CE), the satirist from Samosata on the Euphrates, started as an apprentice sculptor, turned to rhetoric and visited Italy and Gaul as a successful travelling lecturer, before settling in Athens and developing his original brand of satire. Late in life he fell on hard times and accepted an official post in Egypt. Although notable for the Attic purity and elegance of his Greek and his literary versatility, Lucian is chiefly famed for the lively, cynical wit of the humorous dialogues in which he satirises human folly, superstition and hypocrisy. His aim was to amuse rather than to instruct. Among his best works are <i>A True Story</i> (the tallest of tall stories about a voyage to the moon), <i>Dialogues of the Gods</i> (a 'reductio ad absurdum' of traditional mythology), <i>Dialogues of the Dead</i> (on the vanity of human wishes), <i>Philosophies for Sale</i> (great philosophers of the past are auctioned off as slaves), <i>The Fisherman</i> (the degeneracy of modern philosophers), <i>The Carousal or Symposium</i> (philosophers misbehave at a party), <i>Timon</i> (the problems of being rich), <i>Twice Accused</i> (Lucian's defence of his literary career) and (if by Lucian) <i>The Ass</i> (the amusing adventures of a man who is turned into an ass). The Loeb Classical Library edition of Lucian is in eight volumes.

Sommario/riassunto	Popular presentations of history have recently been discovered as a new field of research, and even though interest in it has been growing noticeably very little has been published on this topic. This volume is one of the first to open up this new area of historical research,

introducing some of the work that has emerged in Germany over the past few years. While mainly focusing on Germany (though not exclusively), the authors analyze different forms of popular historiographies and popular presentations of history since 1800 and the interrelation between popular and academic historiography,
