In these and all other relevant respects, this book is usefully varied in examining selected dimensions of economic crisis in relation to important questions of crime and crime control. Specific themes discussed include: corporate crime, money laundering, foreclosures, and mortgage fraud. This volume provides timely analyses of the impact of the current economic crisis, innovative perspectives on problems of economy and finance, and criminological insights on often neglected aspects of social life.
