Sommario/riassunto	This is the first attempt systematically to explain the growth, background and ideology of the Targum to Isaiah. Its principal stages of development between the first and fourth centuries CE are described in order to understand as precisely as possible its hope for God's messianic vindication of his people. Chilton's work demonstrates the paradigmatic significance of the Isaiah Targum within the Prophets Targum as a whole, and convincingly places the Targum in its chronological and theological context.

Sommario/riassunto	In The Continental Shelf Beyond 200 Nautical Miles , Bjarni Már Magnússon explores various aspects of the establishment of the outer limits of the continental shelf beyond 200 nautical miles and maritime boundary delimitations. Special emphasis is laid on the interplay between these processes and the role of coastal States, the Commission on the Limits of the Continental Shelf and international courts and tribunals in this regard. Magnússon convincingly argues that despite the possibility for tension to arise the relationship between the relevant institutions and processes is clear and precise and they together form a coherent system where each separate institution plays its own part in a larger process.
