This book analyses the struggle for these rights by individuals and groups and how this struggle became an essential feature not only in political discourse but also in social and political practice and culture in both Germany and the United States. More specifically, the book examines the different ways rights have been denied due to race, ethnicity, gender and sexual orientation. Considerable attention is given to the impact of Nazism and the struggle for social rights during and after World War II.
