"The book traces the legacy of racism across three continents, from its origins to the present day. With a wide-ranging yet closely-argued style, it brings a sophisticated neo-Marxist analysis to bear on controversial political issues. Mike Cole tackles three countries indepth: the United Kingdom, the United States and Australia. In the UK, he focuses on the effects of colonialism as well as looking at noncolour-coded racism, such as anti-Gipsy, Roma and Traveller racism and xeno-racism - directed at Eastern Europeans.
