#### Sommario/riassunto

The publication deals with individual census actions that took place in Slovakia in the interwar and post-war period. It analyses and evaluates the preparation, the course and partly evaluates the selected results of the censuses. One of the main objectives of the authors was to evaluate the quality of the results of census actions as a historical source.
