Sommario/riassunto

This selection of Arabic and English translations illuminates the changes of eighteenth-century government in the northern Nile Valley of Sudan, and provides reliable chronological points of reference for the history of the region. The documents offered in this volume, including charter grants of land and privilege, administrative letters, judicial rulings, and other official government records, date from 1702 to 1820. This period marks the apogee of the wealth, power, and geographical extent of the realm of the Funji kings of Sinnar who reigned over much of the Sudan
