Sommario/riassunto

In The Lukan Lens on Wealth and Possessions: A Perspective Shaped by Reversal and Right Response, Rachel Coleman offers a detailed look at Luke's wealth ethic. The long-debated question of how Luke understands the relationship between followers of Jesus and material possessions is examined with careful exegesis and keen literary and theological sensitivity. The twin motifs established in Luke's introductory unit (Luke 1:5–4:44)—reversal and right response—provide the hermeneutical lenses that allow the reader to discern a consistent Lukan perspective on wealth in the life of disciples. With an engaging style and an eye to the contemporary church, the book will appeal to both scholars and pastors.

Sommario/riassunto	Military cemeteries are one of the most prominent cultural landscapes of Israel. Their story reflects largely the main social processes that Israeli society has been undergoing since the War of Independence (1948) until today. Until the end of the 1970's, the military tombstones and their surroundings were uniform and equal, according to rules set by the State. However, since the 1980's families of the fallen soldiers started to add on the tombstone personal expressions, as well as personal objects, photographs, military artifacts etc. Thus the military tombstone and the Israeli military cemetery became one of the

expressions of the dramatic transformation, from a society which emphasized the importance of the collective, to a society which intensifies the significance of the individual. The book is based on many archival documents, as well as interviews and photographs, all of which shed light on one of the most sensitive issues in Israeli society and express its importance as a central component of Israeli identity.
