Sommario/riassunto	Roman et fictions brèves mènent, à travers leurs interférences, leurs tensions et leurs diverses formes d'interaction, un dialogue séculaire. Ce dialogue prend, au xixe siècle, une particulière intensité et des

dimensions inédites. Il est ici observé dans les spécificités qu'il présente à cette époque, une époque marquée, notamment, par la reconfiguration du système générique et l'entrée de la littérature dans l'ère médiatique, où règnent le recyclage des écrits, la porosité des frontières, les entrelacs et les hybridations entre les formes. En explorant le « long » xix siècle – de Germaine de Staël à Rosny aîné – le livre examine les multiples modalités de rapprochement ou de croisement du roman et du récit court, ainsi que leurs effets – ou, à l'inverse, leurs stratégies de différenciation. Ces formes littéraires sont donc considérées dans leur réalité historique et dans leur pratique. La dynamique intergénérique à travers laquelle elles sont abordées, plutôt que d'inviter à figer des catégories, ouvre un espace de questionnement. C'est ainsi en acte, et à travers la variété de ses reformulations, que se pose l'incessante question de leurs définitions.

Sommario/riassunto

This book brings together key features of the toxicology and occupational hazards of pesticides and the way their use is regulated in the main trading regions of the world. There are chapters on each of the main groups of insecticides, namely organochlorines, anticholinesterases and pyrethrins and pyrethroids. The book also covers fungicides and herbicides, as well as more specialised agents such as microbial pesticides. The risks and hazards to humans are considered, both occupational and through the consumption of contaminated foodstuffs. Additionally, clinical aspects of pesticide poisoning

Sommario/riassunto

This volume constitutes the proceedings of the 6th IFIP WG 8.1 Conference on the Practice of Enterprise Modeling held in November 2013 in Riga, Latvia. The focus of the PoEM conference series is on advances in the practice of enterprise modeling through a forum for sharing knowledge and experiences between the academic community and practitioners from industry and the public sector. The 19 papers accepted were carefully reviewed and selected from 80 submissions. They reflect different topics of enterprise modeling including quality of models, change management and transformation, approaches and tools for agility and flexibility, enterprise modeling and business processes, enterprise modeling and information systems, and enterprise modeling cases. Additionally, one of the two keynotes is also included in this volume.
