Sommario/riassunto	En materia de teoria general de derechos fundamentales en la Constitucion Espanola, a diferencia de lo que sucede en la doctrina constitucional alemana, la categoria de los derechos de defensa (Abwehrrechte) no ha tenido un excesivo exito ni una utilizacion generalizada en nuestra doctrina y jurisprudencia. Nuestra doctrina e incluso la jurisprudencia ha preferido mantener la distincion de caracter material entre derechos de libertad y derechos sociales, antes de optar por descripciones de caracter prescriptivo como la planteada entre derechos de defensa y derechos de prescripcion. Los derechos de defensa se estructuran en torno a un contenido prescriptivo y una dependencia normativa interrelacionados con unos conceptos juridicos clave como son la libertad, el individuo, el fenomeno asociativo, las

cualidades personales o la posición jurídica. Cada derecho fundamental es susceptible de ser caracterizado de forma independiente, autónoma y separada, pero las categorías jurídicas que los interrelaciona con los derechos de defensa son precisamente el contenido prescriptivo y su diferente dependencia normativa.
