Backed by three decades of experience providing therapeutic programs inside prisons across the United States, trauma specialist Dr. Stephanie S. Covington has used her unique access to amplify the voices of the women themselves. Stories from two dozen interviews with formerly incarcerated women are threaded throughout this journey into the criminal legal system, and their insights ground Covington's analysis. *Hidden Healers* illuminates realities most never see: that the majority who get caught up in the criminal justice system have themselves been victims of harm, that the degradation of today's prisons and jails only magnify their trauma--and that incarcerated women regularly risk punishment to tend to one another's well-being in unexpected acts of kindness. This book explains the dynamics of revenue generation and allocation reality of city corporations in Bangladesh. It explores the state of five consecutive years of revenue generation and expenditure allocations of Dhaka North City Corporation and Gazipur City Corporation along with a discussion of to what extent the City Corporation is allowed to enjoy fiscal autonomy through the Local Government (City Corporation) Act of 2009 to generate and manage its local resources. It also finds out the institutional blocks/challenges that the city corporation faces in the process of revenue generation and mobilization, even with the existence of a solid legislative foundation. Central to the book's focus is the resource mobilizing scenario (generation and allocation of revenue) of City Corporation over the past five consecutive years. It suggests some approaches that will serve as valuable resources for policymakers, researchers, and practitioners to take steps for strengthening the finance base of urban local government through revisiting and redefining revenue generation and allocation strategies.

Muhammad Sayadur Rahman is Professor of Public Administration at Jahangirnagar University, Savar, Dhaka, Bangladesh. He earned his PhD from Heidelberg University, Germany. During more than twenty-two years of involvement in academic and research work, he has been written several books, book chapters, and research articles. His research articles have been published in different refereed national and international journals and he has published many books as well. His research interests center on politics-bureaucracy relations, local governance and development, environmental governance, and public health.

Shamima Akter is currently a freelancer researcher. She received her B.S.S. (Hons) and Master's degree from the Department of Public Administration at Jahangirnagar University, Savar, Dhaka, Bangladesh. She completed her S.S.C from Safiuddin Sarkar Academy School and College and H.S.C from Rajuk Uttara Model College, Dhaka. Her areas of interest are local governance, public policy and governance.

Sommario/riassunto	This book explores the relationship between reading science in fiction and engaging with science. Focusing on embodied readers and empirical approaches to fiction reading, the authors examine

contemporary social, cultural, biographical and political contexts in which science fictions come to matter. Drawing together a distinctive set of research studies and conceptual resources, the book outlines theories, epistemologies and methodologies for understanding how and why we read science fictions and fictions about science. Dr Amy C. Chambers, Manchester Metropolitan University, UK, is a science and screen media scholar focused on the intersection of entertainment media and the public understanding of science. Her research interrogates public and popular cultures of science; marginalised scientific expertise on screen; and women-created science fiction and horror. Her current research project, 'Women Make Science Fiction', constitutes the first comprehensive study of women (inclusive of trans and non-binary) creators of science fiction. Dr Lisa Garforth, Newcastle University, UK, is a sociologist focusing on the relationship between speculative fiction and social futures. A substantial programme of research on Western post-war environmental imaginaries culminated in her monograph *Green Utopias: Environmental Hope Before and After Nature* (2017). She led the Newcastle part of the 3-year, 3-centre AHRC project 'Unsettling Scientific Stories investigating contemporary reading practices, speculative fiction and science. Dr Miranda Iossifidis, Newcastle University, UK, is a sociologist interested the collective and creative negotiation of environmental futures in everyday urban culture, speculative fiction, and collective action. She is currently working on a project using creative methods to explore climate anxiety and speculative ecofascist present(s) and futures. Joanna Verran is Professor of Microbiology (Emeritus) at Manchester Metropolitan University, UK. She is a Principal Fellow of the HEA and a National Teaching Fellow. Her laboratory research focuses on the interaction of microorganisms and inert surfaces, but she has also published widely on innovative practices in teaching and in public engagement with science. She set up the Bad Bugs Bookclub in 2009 with the aim of engaging scientists and non-scientists in discussion about novels of fiction that feature infectious disease or microorganisms.
