Sommario/riassunto

Writing development and pedagogy is a high priority area, particularly with standardised testing showing declines in writing across time and through the years of schooling. However, to date there are relatively few texts for teachers and teacher educators which detail how best to enable the children to become confident, autonomous and agentic writers of the future. *Developing Writers Across the Primary and Secondary Years* provides cumulative insights into how writing develops and how it can be taught across years of compulsory schooling. This edited collection is a timely and original contribution, addressing a significant literacy need for teachers of writing across three key stages of writing development, covering early (4-7 years old), primary (7-12 years old) and secondary years (12-16 years old) in Anglophone countries. Each section addresses two broader themes -- becoming a writer with a child-oriented focus and writing pedagogy with a teacher-oriented focus. Together, the book brings to bear rigorous research and deep professional understanding of the writing classroom. It offers a novel approach conceiving of writing development as a dynamic and multidimensional concept. Such an integrated interdisciplinary understanding enables pedagogical thinking and development to address more holistically the complex act of writing.

Sommario/riassunto

Sein literarisches Werk lässt ihn zu den bedeutendsten Autorinnen und Autoren des 20. Jahrhunderts gehören. Seine Person aber ist heftig umstritten: Gottfried Benn war nicht nur Autor von bahn- und tabubrechenden Werken wie ›Morgue‹, den ›Rönne‹-Novellen oder den ›Statischen Gedichten‹, er hat nicht nur gegen die anerkannten Geschmacksgrenzen verstoßen. Benn hat auch die Grenzen des politisch Tolerierbaren überschritten, als er sich 1933 auf den Nationalsozialismus einließ, die Gleichschaltung der Sektion für Dichtkunst der Preußischen Akademie der Künste betrieb und damit mitverantwortlich für die Vertreibung von Autoren wie Heinrich Mann oder Alfred Döblin gewesen ist. Trotz dieser von umfangreichen Essays begleiteten Entgleisung hat Benns Rang als Lyriker und Essayist literaturhistorisch kaum je in Frage gestanden. Dieser Studien-Band gibt einen Überblick über das Werk Gottfried Benns. Darüber hinaus werden seine Texte neu sondiert und bewertet. Wie sich zeigt, ist Benn nicht nur der Repräsentant eines extremen Expressionismus, einer Dichtung des Elementaren und ein Vertreter einer moderaten Moderne nach 1945 – er hat weder seine Wirkung noch seine Brisanz zu Beginn des neuen Jahrtausends verloren. Und das ist eine literarische Seltenheit.

Sommario/riassunto	"Lviv's Uncertain Destination examines the city's tumultuous twentieth-century history through the lens of its main railway terminal. Whereas most existing studies of eastern European cities centre their stories on

discrete ethnic groups, milestone political events, and economic changes, this book's narrative is woven around an important site within the city's complex spatial matrix. Combining architectural, economic, social, and everyday life history, Andriy Zayarnyuk shows how different political regimes created dissimilar social spaces even on the same streets and in the same buildings. His narrative leads us to rethink how the late imperial Habsburg and Romanov, Stalinist and post-Stalinist Soviet, interwar Polish, and Nazi German regimes produced, structured, and controlled urban space. Focusing on railway workers, the book also draws attention to the history of Lviv's wage earners, who constituted the majority of the city's adult population."--

Sommario/riassunto

In this volume, the relationship between clitics and affixes and their combinatorial properties has led to a serious discussion of the interface between syntax, morphology, semantics, and phonology that draws on a variety of theoretical perspectives (e.g., HPSG, Optimality Theory, Minimalism). Clitic/affix phenomena provide a rich range of data, not only for the identification of an affix vs. clitic, but also for the best way to explain ordering constraints, some of which are contradictory. A range of languages are considered, including Romance and Slavic languages, as well as Turkish, Greek, Icelandic, Korean, and Passamaquoddy. Moreover, several articles consider dialectal microparameterization, notably in Spanish, French, and Occitan. This volume thus reflects current debate on issues such as clitic ordering constraints, the relationship of clitics to inalienable possession and the left periphery, and templatic approaches to affixes vs. clitics while examining a broad range of languages.
