Sommario/riassunto	Icons of Life tells the engrossing and provocative story of an early twentieth-century undertaking, the Carnegie Institution of Washington's project to collect thousands of embryos for scientific study. Lynn M. Morgan blends social analysis, sleuthing, and humor to trace the history of specimen collecting. In the process, she illuminates how a hundred-year-old scientific endeavor continues to be felt in today's fraught arena of maternal and fetal politics. Until the embryo collecting project-which she follows from the Johns Hopkins anatomy department, through Baltimore foundling homes, and all the way to China-most people had no idea what human embryos looked like. But by the 1950's, modern citizens saw in embryos an image of "ourselves unborn," and embryology had developed a biologically based story about how we came to be. Morgan explains how dead specimens

paradoxically became icons of life, how embryos were generated as social artifacts separate from pregnant women, and how a fetus thwarted Gertrude Stein's medical career. By resurrecting a nearly forgotten scientific project, Morgan sheds light on the roots of a modern origin story and raises the still controversial issue of how we decide what embryos mean.

Sommario/riassunto	This open access book discusses cooperation strategies for safeguarding cultural heritage in nations facing diverse forms of fragility. Through case studies and a critical analysis, it explores preserving cultural heritage to spur regional socioeconomic development and community empowerment, focusing on the Middle East and Pakistan, with an in-depht exploration of the World Heritage site of Bamiyan, Afghanistan. The first section offers an overview of cultural heritage protection efforts since UNESCO designated Bamiyan

Valley as a World Heritage Site in 2003, reflecting on challenges and successes before Taliban rule. The second section turns to the present situation, analysing the interplay between heritage preservation, community involvement and policies addressing urban and demographic growth. The third section provides a review of relevant examples of cultural heritage preservation in the Middle East and Pakistan by the Italian Agency for Development Cooperation, UNESCO, and international NGOs. It highlights the relationship between heritage protection, sustainable development and the mitigation of social and economic fragilities. In the concluding section, the book synthesizes research findings and operational approaches, providing a nuanced understanding of the cultural heritage, development, and fragility in the Middle East. Concluding, in the fourth section, the book offers a comprehensive report on main methodological findings, also conferrable to other contexts both in terms of future research and operational activities. .
