Specific Language Impairment (SLI) may be best thought of as probabilistically determined by multiple risk and protective factors. It follows from this that the underlying deficits in SLI may vary requiring different approaches to treatment and allowing for the possibility of different strengths or facilitative effects. Not surprisingly, a range of interventions have been developed. This chapter reviews available approaches and evidence in light of theories related to SLI deficits in domain-specific or domain-general processes, and evidence tapping potential protective factors related to SLI.
