Sommario/riassunto

This volume contains the 14 contributed papers and the contribution of the distinguished invited speaker Béla Bollobás presented at the 3rd Workshop on Algorithms and Models for the Web-Graph (WAW 2004), held in Rome, Italy, October 16, 2004, in conjunction with the 45th Annual IEEE Symposium on Foundations of Computer Science (FOCS 2004). The World Wide Web has become part of our everyday life and information retrieval and data mining on the Web is now of enormous practical interest. Some of the algorithms supporting these activities are based substantially on viewing the Web as a graph, induced in various ways by links among pages, links among hosts, or other similar networks. The aim of the 2004 Workshop on Algorithms and Models for the Web-Graph was to further the understanding of these Web-induced graphs, and stimulate the development of high-performance algorithms and applications that use the graph structure of the Web. The workshop was meant both to foster an exchange of ideas among the diverse set of researchers already involved in this topic, and to act as an introduction for the larger community to the state of the art in this area. This was the third edition of a very successful workshop on this topic, WAW 2002 was held in Vancouver, Canada, in conjunction with the 43rd Annual IEEE Symposium on Foundations of Computer Science, FOCS 2002, and WAW 2003 was held in Budapest, Hungary, in conjunction with the 12th International World Wide Web Conference, WWW 2003. This was the first edition of the workshop with formal proceedings.

Sommario/riassunto

Joy H. Calico examines the cultural history of postwar Europe through the lens of the performance and reception of Arnold Schoenberg's *A Survivor from Warsaw*—a short but powerful work, she argues, capable of irritating every exposed nerve in postwar Europe. Schoenberg, a Jewish composer whose oeuvre had been one of the Nazis' prime exemplars of *entartete* (degenerate) music, immigrated to the United States and became an American citizen. Both admired and reviled as a pioneer of dodecaphony, he wrote this twelve-tone piece about the Holocaust in three languages for an American audience. This book investigates the meanings attached to the work as it circulated through Europe during the early Cold War in a kind of symbolic musical remigration, focusing on six case studies: West Germany, Austria, Norway, East Germany, Poland, and Czechoslovakia. Each case is unique, informed by individual geopolitical concerns, but this analysis also reveals common themes in anxieties about musical modernism, Holocaust memory and culpability, the coexistence of Jews and former Nazis, anti-Semitism, dislocation, and the presence of occupying forces on both sides of the Cold War divide.
