Sommario/riassunto	Die gesellschaftliche Relevanz visueller Kommunikation nimmt immer weiter zu. Postmoderne Bildparodien sind Teil dieser Kultur. Dabei erschöpfen sie sich nicht im Aspekt des Komischen. Johanna Hornauer erläutert am Beispiel ausgewählter Werke von Sigmar Polke, dass Bildparodien eine kritische Auseinandersetzung mit Geschichte als autoritativer Instanz darstellen. Ihre Untersuchung von postmodernen Bildparodien als ästhetischer Praxis und Intervention in bestehende (Herrschafts-)Diskurse entwickelt neue Analysestrategien und fordert damit unter medienkritischer Perspektive ein generelles »Lesenlernen« von Bildern, das im Museum ebenso nützlich ist wie auf Social Media.
