Critics maintain that the two countries suffer from a "democratic deficit," a deficit that raises profound questions about the legitimacy and effectiveness of their democratic institutions. Imperfect Democracies brings together Canadian and American scholars to compare and contrast the democratic deficit in the two nations. Blending normative theory and empirical analysis, they focus on three key questions: Why talk about a democratic deficit? In what ways are Canadian and American democracies falling short? What can be done to remedy the deficit?
